- 6) You will not bring any alcoholic beverage onto or around the field before, during or after any practice or game.
- 7) You will demand a sports environment that is free from drugs and tobacco.
- 8) You will teach your child, by example, to treat other players, coaches, fans and officials with respect regardless of their race, gender, creed or ability.
- 9) You will help your child to enjoy the youth sports experience by doing whatever you can, such as being a respectful fan and helping the coach and the organization in whatever way you can.
- 10) You will do everything you can to help your child to have a fun and happy sports experience.

I/We understand that if we choose not to accept this Code My/Our child may not be permitted to participate in this program. I/We understand that if I/We violate this Code then I/We may be suspended from attending any Youth function sponsored by LRPD. I/We also understand that if I/We violate this Code My/Our child could be suspended from participating in any Youth program sponsored by LRPD. I/We understand that by accepting this Code both Parents/Legal Guardians agree to the content of this Code.

As the parent or legal guardian of the registering player(s), I hereby give my consent that such player(s) likeness may be photographed or videotaped and that such image may be published in an outlet used to promote or publicize the sports program, including but not limited to the CSA website.

RESIDENCY

As a parent or legal guardian of the Youth Athlete listed on this registration, I hereby certify and affirm that this child does legally and actually reside at the address listed. I understand that if my child is found to be actually living at an address other than the one listed, he or she is subjected to being suspended from the Lafayette Consolidated Government Recreation Program for at least one year and that I, as a parent or guardian will also be subject to suspension for a period of 2 years. If a child is found to be participating in an incorrect neighborhood association, he/she will be reassigned to the correct neighborhood association at once, even if the regular season has already started.
